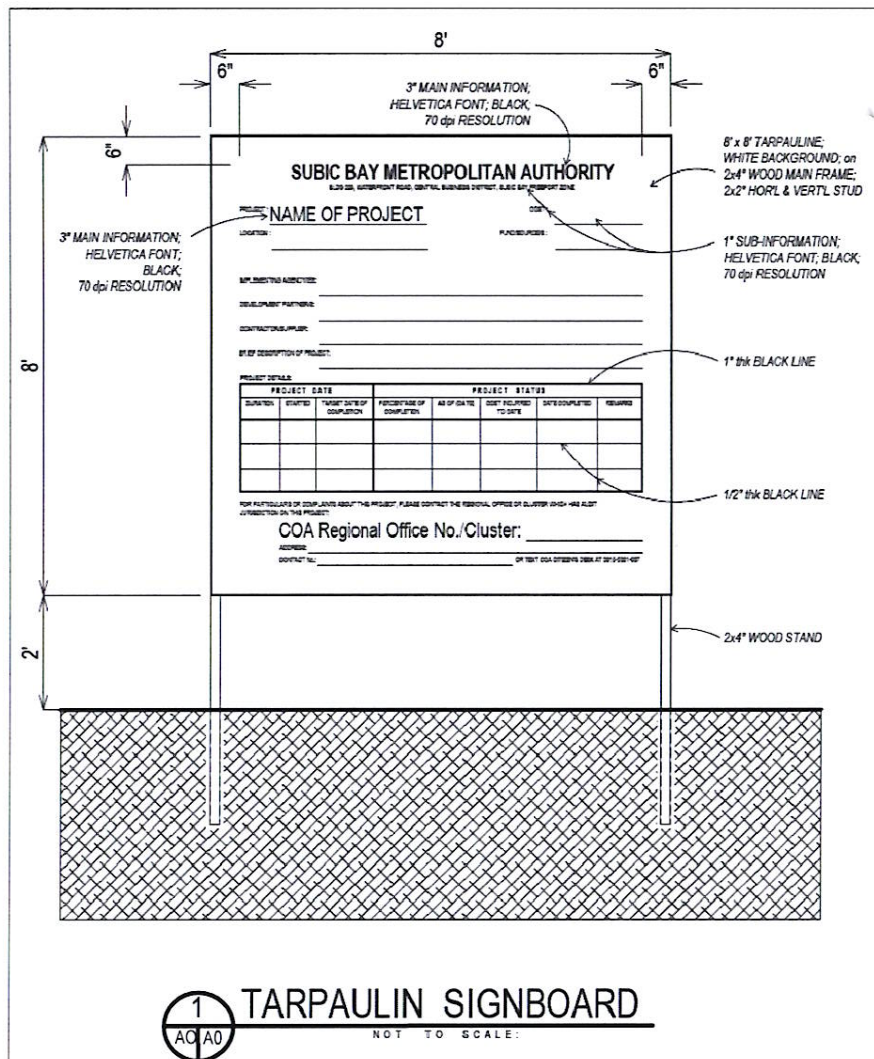


RENOVATION OF GBID OFFICE AT BLDG # 662

LOCATION: BLDG 662 TAFT ST. COR DEWEY AVE. SBFZ



GENERAL NOTES :

1. THE CONTRACTOR SHALL PROCURE/SECURE ALL CONSTRUCTION PERMITS REQUIRED (i.e. BUILDING PERMIT, HOT WORKS PERMITS, ETC.)
2. THE CONTRACTOR SHALL PERFORM ALL WORKS NECESSARY TO COMPLETE THE PROJECT IN ACCORDANCE WITH THE APPROVED CONSTRUCTION DRAWINGS, INCLUDING ANY INCIDENTALS AS MAY BE NECESSARY TO COMPLETE THE PROJECT.
3. THE CONTRACTOR SHALL MAINTAIN ONE (1) COMPLETE SET OF APPROVED CONSTRUCTION DRAWINGS ON THE SITE/FIELD OFFICE AND BE MADE AVAILABLE TO THE PROJECT ENGINEER AT ALL TIMES. AS MAY BE NECESSARY TO COMPLETE THE PROJECT.
4. DIMENSIONS SHOWN ARE ALL MILLIMETER/METER. SCALE USED MAY VARY IN ACTUAL PRINTOUT DUE TO PRINTING/PHOTOCOPYING PROCESS
5. DISCREPANCIES BETWEEN ACTUAL CONDITION AND THESE DRAWINGS SHALL BE BROUGHT TO ATTENTION OF THE PROJECT ENGINEER IMMEDIATELY AND THE CONTRACTOR SHALL SUBMIT SPECIFIC DISCREPANCY REPORT FOR NECESSARY ACTIONS
6. ANY DISCREPANCIES BETWEEN THE CONSTRUCTION DRAWINGS AND THE TECHNICAL SPECIFICATIONS, THE CONSTRUCTION DRAWINGS SHALL PREVAIL
7. ALL WORKS THAT MAY CREATE LOUD NOISE/DISTURB NEARBY OFFICES DURING THE COURSE OF THE PROJECT BE SCHEDULED DURING WEEKEND OR BE MINIMIZED AS MUCH AS POSSIBLE
