## RESOLUTION NO. 021-FNP-2020

**WHEREAS**, the SUBIC BAY METROPOLITAN AUTHORITY (SBMA) advertised the Invitation for Negotiated Procurement Under Two-Failed Bidding for the procurement of the **One (1) Year Contract of Fuel Supply** posted on the SBMA website, the G-EPS and in a conspicuous place within the Subic Bay Freeport Zone for 14 days;

**WHEREAS**, in response to the advertisement, one (1) proponent registered for the Negotiated Procurement Under Two-Failed Bidding, namely, PETROL REPUBLIC PHIL.,INC.;

**WHEREAS**, during the Submission/Opening of Negotiated Procurement scheduled on March 2, 2020, PETROL REPUBLIC PHIL., INC. was able to submit its bid for the project. However, PETROL REPUBLIC PHIL., INC. was disqualified due to non-submission under Tab A(d) – 2018 Audited Financial Statement;

**WHEREAS**, upon query, the PETROL REPUBLIC PHIL., INC. will no longer submit a request for reconsideration;

**WHEREAS**, under Sec. 35.1 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, when all prospective bidders are declared ineligible, the BAC shall declare the bidding/negotiated procurement under two-failed bidding a failure;

**NOW, THEREFORE, premises considered, WE the Members of SBMA Bids and Awards Committee (BAC) for Goods and Services, hereby RESOLVED to declare the bidding for the the One (1) Year Contract of Fuel Supply a failure.**

Accordingly, in order to determine the reason for the failed NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDING, a mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates shall be conducted.


**RESOLVED further**, that after the necessary revisions in the terms, conditions and specifications in the bidding documents resulting from the aforementioned mandatory review and evaluation, **to conduct another procurement process for the project through Negotiated Procurement Under Two-Failed Bidding.**
